There is a limited number of tables, so we encourage you to send in your reservation as soon as possible. Spaces will be reserved on a first-come, first-served basis for paid reservations.

### Location

The Tack Swap and Fundraiser will be located in the Manitowoc County Expo Merchants Building.

### Operation

This event is NOT the consignment sale as we have held in the past! You reserve a space to sell or promote your own items. No commission taken on sold items.

### Exhibit Areas & Amenities

- Indoor 10'x7' (approx.) Individual spaces
- Indoor 15'x15' Commercial spaces
- Outdoor 15'x25' spaces
- **Electrical service is available at no charge, but must be requested in advance.** Please provide your own 3-prong long extension cords and power strips.
- Tables and chairs are available for rent (indoor spaces only)

### Set-up

Setup time from 7 am to 9 am. Overhead doors available for large items or displays. Exhibitors must be ready for business by 9 am. Exhibits may not extend into aisles, and all aisles are to be kept clear of merchandise and signs.

Exhibits must be removed from the premises by 5 pm.

### Pets

**Only service dogs are allowed in the building - NO EXCEPTIONS!**

### Liability

Horse-A-Rama Inc, Manitowoc County, Mani-towoc County Expo, or any personnel connected with these groups will not be held liable for loss, theft, injury, or damage of any kind.

### Reservation Completion & Payment

Reservation form should be completed legibly, in full, signed and accompanied by a non-refundable payment. Make a photocopy for your records.

All reservations are on a first-come, first-serve basis. HAR will not accept reservations without payment. The deadline for reservation submission and full payment is **March 1, 2017**. After March 1<sup>st</sup>, call or email for availability.
